WHAT TO FILE:

WHEN TO FILE:

WHERE TO FILE:

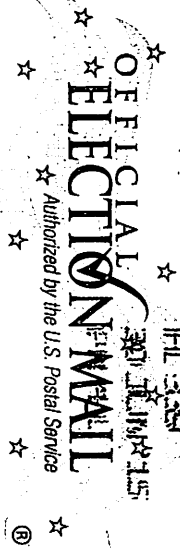
