WHAT TO FILE:

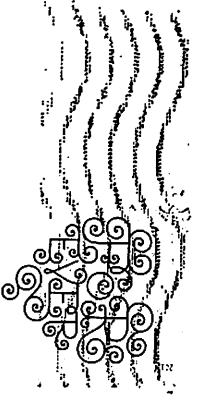
NOTE:
