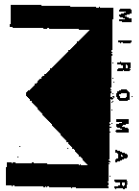

If you are leaving office or employment during the first half of 2012, you may not have filed Form 1 for 2011. You will be required to file Form 1 for 2011 by July 1, 2012, and risk being fined if you do not file Form 1 by the filing deadline, even if you have already filed the CE Form 1F.
