WHAT TO FILE:

NOTE:

MULTIPLE FILING UNNECESSARY:

Generally, a person who has filed Form 1 for a calendar or fiscal year is not required to file a second Form 1 for the same year. However, a candidate who previously filed Form 1 because of another public position must at least file a copy of his or her original Form 1 when qualifying.

WHERE TO FILE:

If you were mailed the form by the Commission on Ethics or a County Supervisor of Elections for your annual disclosure filing, return the form to that location.

WHEN TO FILE:

Initially, each local officer/employee, state officer, and specified state employee must file **within 30 days** of the date of his or her appointment or of the beginning of employment. Appointees who must be confirmed by the Senate must file prior to confirmation, even if that is less than 30 days from the date of their appointment.

Candidates for publicly-elected local office must file at the same time they file their qualifying papers.

Thereafter, local officers/employees, state officers, and specified state employees are required to file by July 1st following each calendar year in which they hold their positions.

Finally, at the end of office or employment, each local officer/employee, state officer, and specified state employee is required to file a final disclosure form (Form 1F) within 60 days of leaving office or employment. However, filing a CE Form 1F (Final Statement of Financial Interests) does not relieve the filer of filing a CE Form 1 if he or she was in their position on December 31, 2012.

Records in this office indicate that you were mailed a financial disclosure packet, and advised of the July 1, 2013 deadline for filing Form 1 Statement of Financial Interests on or about May 23, 2013.

The initial disclosure packet you were mailed has not been returned by the United States Postal Service, and there is no record of your having filed your Form 1 Statement of Financial Interests for 2012, with this office, as required.

Please note that persons serving as of December 31, 2012, along with officials elected in 2012, whose terms began in January 2013, are required to file this year.

EVEN IF YOU LEFT YOUR POSITION DURING 2013, YOU ARE STILL REQUIRED TO FILE FINANCIAL DISCLOSURE FOR 2012. If you left your position during 2013, you are also required to file a (FORM 1-F FINAL STATEMENT OF FINANCIAL INTERESTS FOR 2013) that covers the portion of 2013 you served.

Pursuant to Florida law, you are hereby notified that you are delinquent in filing Form 1 Statement of Financial Interests for 2012. A grace period is now in effect until September 3, 2013. If your Form 1 is not received by September 3, 2013, a fine of \$25 for each day late will be imposed, up to a maximum penalty of \$1,500. In addition, we are required, by law, to notify the Florida Commission on Ethics of the delinquency; and that, if upon the filing of a sworn complaint the Commission finds that the person has failed to timely file the statement within 60 days after September 3, 2013, such person will also be subject to the penalties provided in Florida Statutes §112.317.

Enclosed is a Form 1 Statement of Financial Interests for 2012, a Form 1 Checklist, and a courtesy return-envelope to facilitate the filing of your Form 1 before September 3, 2013. You may also download Form 1 from the Florida Commission on Ethics web site, <http://www.ethics.state.fl.us>.

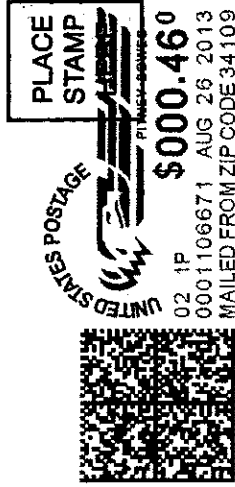
