Thereafter, local officers/employees, sta officers, and specified state employed are required to file by July 1st followir each calendar year in which they hold the positions.

Finally, at the end of office or employment each local officer/employee, state officer, ar specified state employee is required to file final disclosure form (Form 1F) within 60 day of leaving office or employment. Howeve filing a CE Form 1F (Final Statement Financial Interests) does not relieve the fi of filing a CE Form 1 if he or she was in the position on December 31, 2012.
