**WHAT TO FILE:**

**WHERE TO FILE:**



**NOTE:**



You will be required to file Form 1 for 2013 by July 1, 2014, and risk being fined if you do not file Form 1 by the filing deadline, even if you have already filed the CE Form 1F.
