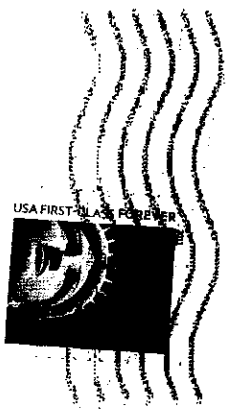
NOTE:
