WHAT TO FILE:

WHEN TO FILE:

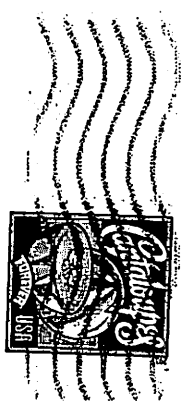
