**WHERE TO FILE:**

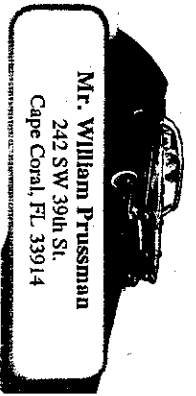
