**WHAT TO FILE:**

**WHEN TO FILE:**

**WHERE TO FILE:**

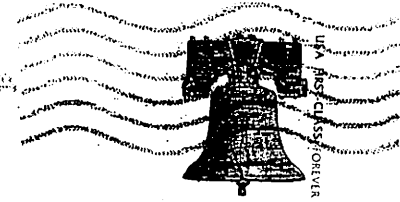

You will be required to file Form 1 for 2014 by July 1, 2015, and risk being fined if you do not file Form 1 by the filing deadline, even if you have already filed the CE Form 1F.
