Persons serving as of December 31, 2007 (along with those officials elected in 2007 whose terms began in 2008) are STILL required to file in 2008 for the year ending 12-31-2007. Even if you left the your position in 2008, you are required to file financial disclosure <u>for 2007</u> on the enclosed form.

## IT IS IMPORTANT THAT YOU RETURN YOUR COMPLETED FORM 1 STATEMENT OF FINANCIAL INTEREST IMMEDIATELY IN ORDER TO CLOSE YOUR FILE WITH THE LEE COUNTY SUPERVISOR OF ELECTIONS AND AVOID FUTURE MAILINGS AND/OR A FINE FOR A LATE FILING.

## WHEN TO FILE: By July 1, 2008

Persons who fail to file the annual disclosure form by <u>September 1st</u> are subject to <u>automatic fines of \$25.00</u> for each late day up to \$1,500.

- <u>WHERE TO FILE</u>: Please return the completed <u>ORIGINAL</u> form, including signature and date in the enclosed postage-paid return envelope to: LEE COUNTY ELECTIONS OFFICE, POST OFFICE BOX 2545, FORT MYERS FL 33902-2545. THE ROLE OF THE SUPERVISOR OF ELECTIONS IS TO RECEIVE AND MAINTAIN THE FINANCIAL DISCLOSURE FORM AS A PUBLIC RECORD.
