WHAT TO FILE:

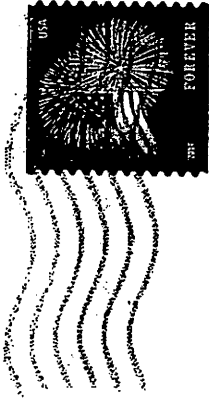
