WHAT TO FILE:

WHERE TO FILE:

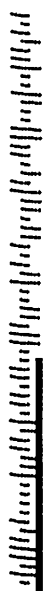

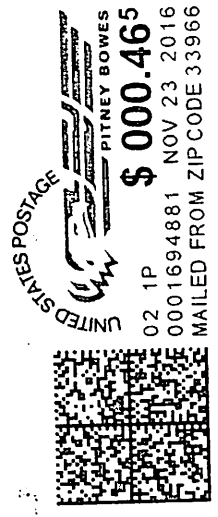
