WHAT TO FILE:

WHEN TO FILE:

WHERE TO FILE:

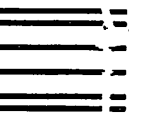

You will be required to file Form 1 for 2015 by July 1, 2016, and risk being fined if you do not file Form 1 by the filing deadline, even if you have already filed the CE Form 1F.
